## Instructions to the candidates

- 1. The application should be filled in clearly and legibly (Typed or Hand written).
- 2. Answer each item clearly and completely.
- 3. Applications should be signed and duly filled in all respects with relevant information sought only. Avoid extraneous information. Furnish content sheet with page numbers.
- 4. The application downloaded from website should accompany the requisite processing fee (Non-Refundable) Rs.1,000/- as demand draft in favor of "ICAR-Taralabalu Krishi Vigyan Kendra payable at Davanagere" as indicated in the notification, at the time of submission of filled in application, or else, the application will be rejected. "Scheduled Castes (SC), Scheduled Tribes (ST), Persons with Benchmark Disabilities (PwBD), Ex-servicemen (ESM), and women candidates are exempted to submit the processing fee.
- 5. The Maximum Age Limit for the Post of Subject Matter Specialist should not exceed 35 Years as on closing date of application.
- 6. Age relaxation to SC/ST/OBC/PH candidates will be given as per Government of India rules.
- 7. All supporting documents in the form of hard copies must be enclosed with the application, page numbered and arranged in chronological order as per the application format.
- 8. The entire notification along with the detailed qualification and application pro-forma prescribed for the post notified is accessible from the website <a href="https://www.taralabalukvk.com">https://www.taralabalukvk.com</a>. The candidates have to download the application pro-forma through our official website only.
- 9. Candidates are informed to submit their signed and duly filled in application with relevant documents attested by Gazetted Officer to "The Secretary, Taralabalu Rural Development Foundation, ICAR-Taralabalu Krishi Vigyan Kendra, Kadalivana, Taralabalu KVK Road, LIC Colony Layout, Davanagere 577 004, Karnataka" within 30 days from the date of advertisement in Employment News.

- 10. The last date for receipt of application will be 30 days from the date of publication of advertisement in Employment News. If the last date happens to be a Sunday or Closed Holiday, the next working day will be taken as crucial date. The crucial date for determining the age limit shall be the closing date for receipt of application from candidates.
- 11. KVK and Taralabalu Rural Development Foundation, Sirigere or ICAR will not be responsible for any postal/ Courier delay.
- 12. The candidate should be himself/herself ensure his/her eligibility for the post applied for, before submission of application. No correspondence, whatsoever, in this regard shall be made/entertained later.
- 13. Candidates already in service (Government / Quasi Government / Private) should submit their applications through proper channel. Employed applicant should send the applications through their employer with Original 'No Objection Certificate'. They should also ensure that the application reaches KVK on or before the last date prescribed. If any delay in sending the application through proper channel is anticipated, an advance copy of the application should be sent within the last date prescribed. However, original NOC should be produced before appearing for the written test.
- 14. Applicants are required to send copies of statement of marks in the different examinations and copies of certificates furnishing the service particulars along with the application.
- 15. Applications must be accompanied by Gazetted officer attested copies of all the documents like Marks Sheets, Certificates, Experience Certificates, Publications, Research Notes, Certificates of Awards/Medals, Certificate related to past service etc. and the details of research or related publication, if any, in support of eligibility.
- 16. The envelope in which application is being sent should be superscribed with the name of the post applied.
- 17. Written test will be conducted for shortlisting the candidates.
- 18. Applicants, if called for interview should be prepared to appear before the selection committee, at their own cost at the place indicated.
- 19. KVK is functioning as prescribed under the Act and Statutes of TRDF. KVK Staff are borne on the establishment of TRDF and no liability of gratuity, post-employment if KVK is closed, leave salary, NPA, Pension Contribution shall be liable from ICAR and TRDF, Sirigere.
- 20. Any pressure brought on the selection committee or the members of the Board of Directors by a candidate will disqualify the candidature for the post.
- 21. The candidates who have studied under Trimester system and other than 10 point grading system are required to produce the equivalent percentage certificate obtained from the respective University.
- 22. Pay & Allowances (Basic, DA, HRA) permitted by ICAR only will be payable to the selected candidate.
